Introduction

It is our policy that all children should wear school uniform when attending school, or when participating in a school-organised event outside normal school hours. We provide a complete list of the items needed for school uniform on the school website.

Aims and objectives

Our policy is based on the shared understanding that a school uniform:

- promotes a sense of pride in the school;
- engenders a feeling of community and belonging;
- is practical and smart;
- identifies the children with the school;
- is not distracting in class (as fashion clothes might be);
- makes children feel equal to their peers in terms of appearance;
- is regarded as suitable and good value for money, by most parents;
- and has been designed with health and safety in mind.

School Uniform

***Clothing is available with Village branded logos. However, this is optional and not a requirement. Items can be purchased from a range of suppliers including all major supermarket chains or more local specialised shops. School also keeps a certain amount of second-hand clothing for parents to utilise where necessary.**

PE Uniform

PE kit consists of plimsolls/trainers, a light blue plain T shirt and black plain shorts. **(required)**

School also recommends a dark plain tracksuit for outdoor PE during the cooler winter months. Sports branded clothing and football kits are not permitted in school for PE lessons or sports clubs. School football kit will be provided to students for competitions.

Uniform Purchase

Specific items of school uniform such as jumpers, cardigans, ties, school book bags and PE bags can be purchased directly from the school uniform supplier premises; Motif8.

Name labels

We strongly urge all parents to label all items of their children's clothing as this assists when items of uniform are lost during the day. The suppliers of school uniform will, for a small charge, add a child's initials in embroidery to a school uniform, jacket or book bag. Only a child's initials may be added to uniform not full names or nicknames.

Jewellery

On health and safety grounds we do not allow children to wear jewellery in our school. The exceptions to this rule are small (not dangling) ear-ring studs in pierced ears. Watches are also permitted. Earrings and watches must be removed during PE and games on health and safety grounds. Staff are not permitted to remove earrings. School takes no responsibility for their safe keeping.

Nail Varnish/false nails /Transfers/Make-up/False or Spray

Children should not wear nail varnish/false nails / false eye lashes / transfers/make- up/spray or false tan for school.

Hair

- All children are requested to tie hair up where it is long enough to do so. This is for both health and safety reasons and to look smart and ready for school.
- Hair must be tied up in PE.
- In swimming we request that children wear a swimming cap or tie long hair up.
- Large hair adornment such as large bows are not permitted.
- Non-regulation hairstyles are not part of school uniform and should not be worn. These include:
 - Patterns cut into the hair
 - Hair that is long in parts and very short elsewhere
 - Hair dyed, either wholly or partly, in a non-natural hair colour.

Footwear

- The school wants all children to grow into healthy adults. We believe that it is dangerous for children to wear shoes with platform soles or high heels in school, so we do not allow this.
- Neither do we allow children to wear coloured trainers to school; black plain trainers are permitted and are in keeping with the smart appearance of a school uniform.
- We require all children to wear the types of shoe described in the uniform list.

The role of parents

We ask parents who chose to send their children to our school to support the school uniform policy. We believe that parents have a duty to send their children to school correctly dressed and ready for their daily schoolwork. Parents should ensure that their child has the correct uniform, and that it is clean and in good repair.

If any parent would like the school to modify the uniform policy, they should make representation, in the first instance, to the SENDCO or Head Teacher. The school welcomes children from all backgrounds and faith communities. If there are serious reasons, for example religious objections, why parents want their child to wear clothes that differ from the school uniform, the school will look sympathetically at such requests. Similarly, should an item of school uniform prove problematic for a pupil with disabilities, then parents are invited to draw this to the attention of the Head Teacher. The school will not treat pupils with disabilities unfavourably.

The role of governors

The governing body supports the Head Teacher in implementing the school uniform policy. It considers all representations from parents regarding this policy, and liaises with the Head Teacher to ensure that the policy is implemented fairly and with sensitivity.

It is the governors' responsibility to ensure that the school uniform meets all national regulations concerning equal opportunities, and that our school uniform policy is consistent with our policy on equal opportunities.

Governors ensure that the school uniform policy helps children to dress sensibly, in clothing that is hard wearing, safe and practical.

Pupil non-compliance

The Head Teacher, or a person authorised by the Head Teacher, may ask a pupil to go home briefly to remedy a breach of the school's rules on appearance or uniform. When making this decision the school will consider the child's age and vulnerability, the ease and time it will take, and the availability of the child's parents. This is not an exclusion but an authorised absence.

If the pupil continues to breach uniform rules in such a way as to be sent home to avoid school, or takes longer than is strictly necessary to effect the change, the pupil's absence may be counted as an unauthorised absence. In either case the pupil's parents will be notified and the absence should be recorded.

If this matter continues the school may consider internally excluding a pupil in response to breaches of uniform policy. This will be in line with the legal requirements for exclusion.

Monitoring and review

When monitoring this policy, through its committee work, the governing body will:

- seek the views of parents, to be sure that they agree with the policy, and support it;
- consider with the head teacher any requests from parents for individual children to have special dispensations;
- require the head teacher to report to the governors on the way the policy is being implemented.

This policy will be reviewed by the governing body every two years or earlier if necessary.
